**PROMOTION OVERVIEW – HOW TO PARTICIPATE**

- The Harrah's Total Rewards® 2008 Great Gift Wrap Up ("Promotion") is a shopping extravaganza which any Total Rewards® member that plays at any of seven participating Harrah's owned or affiliated properties in Las Vegas, Nevada, from **12:00 a.m. January 1, 2008 through 6:00 p.m. on December 7, 2008** ("Promotion Period") can participate in. Throughout the Promotion Period, all Total Rewards® members that play at any of seven participating Harrah's owned or affiliated properties in Las Vegas, Nevada can earn bonus "Gift Points" on top of their Reward Credits. These Gift Points can then be redeemed in Las Vegas, Nevada, for fabulous gifts during two separate week-long Promotion Shopping Events in November, 2008 and December, 2008. (hereinafter referred to as the “Harrah’s Las Vegas Properties”).

## **ELIGIBILITY**

- Everyone with a Total Rewards<sup>®</sup> card who plays slots or table games at any one of the seven participating Harrah’s Las Vegas Properties during the Promotion Period will earn Gift Points.

## **HOW TO EARN GIFT POINTS<sup>i</sup>**

- For every Reward Credit (Base or Bonus) you earn from your play from 12:00 a.m. PST on January 1, 2008 to 6:00 p.m. PST on December 7, 2008 at the Harrah’s Las Vegas Properties, you will receive approximately one Gift Point. There may be special days where you will receive more. Management also reserves the right, in its sole discretion, to allow alternative methods for obtaining Gift Points on the days of the Promotion Shopping Events (as defined below). You will only receive Gift Points for play at the participating Harrah’s Las Vegas Properties. The Promotion is not available anywhere else.
- Unredeemed Gift Points expire December 7, 2008 at 6:00 p.m. PST.
- Gift Points are a bonus provided **IN ADDITION** to Reward Credits (Base or Bonus) already earned, and do not affect Reward Credit balance. Gift points have no cash value.
- Reward Credit Multipliers are not applied to Gift Points. On promotional days, Gift Points will be earned based on the actual Base and Bonus Reward Credits earned before the multiplier is applied. Gift Points are not earned for promotional Reward Credits, such as those won during Hidden Jackpots or those redeemed via an offer. Reward Credits awarded via the Total Rewards Visa<sup>®</sup> program are ineligible to earn Gift Points. Reward Credits awarded via the Total Rewards Non Gaming Program are ineligible to earn Gift Points.
- Gift Point balance<sup>ii</sup> may be checked while in Las Vegas by visiting any Total Rewards<sup>®</sup> booth at any Harrah’s Las Vegas Property, or check your e-mail account and your mailbox because you may be notified periodically of your Gift Point balance. - Points are exclusive to each individual and can only be combined between customers who are married or customers in domestic partnerships with associated accounts. In these cases, both parties must be present at the Promotion event to combine their points.

## **HOW TO REDEEM GIFT POINTS<sup>ii</sup>**

- You must attend one or both of the Promotion Shopping Events in person in Las Vegas, Nevada, to redeem Gift Points.
- You may call 1-866-WRAPUP1 to reserve a hotel room.
- During the Promotion Shopping Events, Gift Points may be redeemed for various types of consumer merchandise (“Gifts”) <sup>iii</sup>.
- You can also use your Gift Points for trips ranging from a European driving experience to a New York City getaway.

**DELIVERY OF GIFTS**<sup>iv</sup>

- When Gift Points are redeemed during the Promotion Shopping Events, all Gifts are shipped directly to the mailing address you provide when you redeem your Gift Points.
- International shipping of the Gifts is available to Canada only. Additional charges may apply.

<sup>i</sup> 1 to 1 Reward Credit to Gift Point Ratio will not be applicable during Reward Credit Multiplier days or promotional Total Rewards events (ex. Hidden Jackpots) unless otherwise noted – players will earn Gift Points based on Las Vegas play as if a non-promotional day. Please contact the Total Rewards desk for more information.

<sup>ii</sup> Gift Points can only be redeemed in person during the assigned Promotion Shopping Events in Las Vegas, Nevada. You must be in attendance in person at a Promotion Shopping Event in Las Vegas, Nevada, to redeem Gift Points – you cannot call in or have a host redeem for you.

## **GENERAL PROMOTION RULES**

As used herein "Harrah's" means Bally's Las Vegas, Caesars Palace Las Vegas, Flamingo Las Vegas, Harrah's Las Vegas, Imperial Palace Hotel & Casino, Paris Las Vegas, Rio Suites Hotel & Casino, and all of their parent, affiliated, and subsidiary companies.

- Void where prohibited or restricted by law.
- Must be at least 21 years of age to participate, and participants must provide valid proof of age.
- All participants must have a Total Rewards<sup>®</sup> Card; Total Rewards<sup>®</sup> Cards are free and are available at the Total Rewards<sup>®</sup> Center.
- This Promotion is subject to all applicable federal and/or state rules and regulations, including gaming, and all aspects of the Promotion are subject to the approval of appropriate regulatory authorities and is void where prohibited.
- Participants must show their Total Rewards<sup>®</sup> Card and valid picture identification (driver's license, state identification card, or military identification card) in order to redeem Gift Points. If participant is not a U.S. citizen, a current passport or alien registration card is required.
- Participants are responsible for any and all taxes (income or sales), licenses, registrations and other government imposed fees.
- If Harrah's chooses to secure additional documents as Harrah's may reasonably require relating to this Promotion and its rules, including but not limited to affidavits of eligibility/release, tax documents or other similar agreements, then each participant agrees to sign the same upon Harrah's request.

- In Harrah's sole discretion, Harrah's may deny participation in the Promotion, may offset any Gift award and/or the cash value of any Gift or may withhold any Gift Points or Gift award if the participant has any outstanding obligation due and owing to Harrah's.
- Harrah's may disqualify any person for any Gift Points or Gift based upon fraud, dishonesty, violation of promotional rules or other misconduct whether or not directly related to this Promotion.
- Harrah's is not liable for injuries or losses arising or resulting from participation in the Promotion and is not liable for acts or omissions by employees, whether negligent or willful,

in the conduct of the Promotion (including, but not limited to, erroneous calculation of Gift Points or communication regarding same) and is not liable in the event of any equipment or software malfunction.

- Any attempt by any person to deliberately damage any program or website or to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws and should such an attempt be made, Harrah's reserves the right to seek damages from any such person to the fullest extent of the law.
- Gifts and Gift Points are non-transferable.
- All participation will be retained for record keeping purposes in accordance with local regulatory policies.
- Must be present during the Promotion Shopping Events in Las Vegas, Nevada, to redeem Gift Points.
- Employees of Harrah's and its subsidiaries, affiliates, or parent companies and immediate family members of employees who are (i) director level or above and/or (ii) involved in coordinating or executing promotions or tournaments are not eligible for this Promotion. Immediate Family is defined as: spouse, child or anyone sharing the same residence as the applicable employee.
- Individuals who are excluded from casino facilities, including through a government program, at Harrah's discretion, or by their own request, are not eligible.
- By participating in this Promotion, participants agree to the rules.
- A copy of these rules will be available at the Total Rewards® Center throughout the duration of this Promotion.
- Participants' slot play and table game play must be tracked in order to receive Gift Points. Gift Points for this Promotion cannot be accumulated through any other means. Any Total Rewards® credits received for any non-gaming purchases or for customer service issues will not be considered for Gift Points.
- Non-tracked play will not be considered for Gift Points.
- Slot players must insert their Total Rewards® card while playing slots in order to receive Gift Points. It is the slot player's responsibility to make certain the card reader is operational when inserting his/her Total Rewards® card. Total Rewards® cards must be used continuously during play to receive an accurate reading of tracked play.

- Table game players must turn their Total Rewards® card in to the dealer to have their play tracked in order to receive tracked play Gift Points. Harrah's uses reasonable efforts to track a table game participant's average bet and length of play. However, as a condition of receiving Gift Points for playing table games, all Promotion participants agree that such tracking is based on the personal observation of Harrah's employees, which is subject to error. The determination of Harrah's shall be final with respect to any discrepancies regarding tracked table play.
- Gift Points obtained via tracked slot and/or table play will automatically become part of the Gift Point database. Tracked slot and/or table play Gift Points may not be accessed immediately due to the delay in data input or random system overload.
